I represent that I have been informed that:

1. Miedzynarodowe Targi Gdanskie SA [MTG SA Gdansk International Fair Co.] with its registered office at ul. Zaglowa 11, 80-560 Gdansk, Poland, KRS No. 0000038362, is the Controller of my personal data (hereunder: "Data Controller"),
2. my personal data will be processed for information, advertising and promotion purposes and for the purposes of organising and holding the International Fair of Amber & Jewellery Amberif organised by the Data Controller in 2022 and in subsequent years, and for the purpose of compliance with the legal obligations of the Data Controller (in particular as regards tax settlements and accounting documentation),
3. my personal data will be processed on the basis of: GDPR Article 6.1.a) (i.e. freely given consent), GDPR Article 6.1.c) (i.e. compliance with the legal obligations to which the Data Controller is subject as regards tax settlements and accounting documentation) and GDPR Article 6.1.f)—legitimate interests of the Data Controller (i.e. direct marketing purposes of the Data Controller, especially related to the advertising, promoting, organising and holding of the International Fair of Amber & Jewellery Amberif, organised by the Data Controller in 2022 and in subsequent years),
4. recipients of my personal data may include the organisers and participants of the International Fair of Amber & Jewellery Amberif organised by the Data Controller in 2022 and in subsequent years, as well as entities which maintain the IT infrastructure, entities which provide consulting, legal and security services to the Data Controller,

8. I have the right to lodge a complaint with the President of the Polish Personal Data Processing Authority (UODO), which is an independent supervisory authority referred to in GDPR Article 4.21,
9. I have the right to withdraw this consent at any time, without affecting the lawfulness of processing based on the consent before its withdrawal,
10. this data processing consent has been given by me freely and does not result from a statutory or contractual requirement; however, the providing of this consent is a condition to properly meet the purposes specified in Clauses 2 and 3 above,
