- 1. Miedzynarodowe Targi Gdanskie SA [MTG SA Gdansk International Fair Co.] with its registered office at ul. Zaglowa 11, 80-560 Gdansk, Poland, KRS No. 0000038362, is the Controller of my personal data (hereunder: "Data Controller"),
- 2. my personal data will be processed for information, advertising and promotion purposes and for the purposes of organising and holding the International Fair of Amber & Jewellery Amberif organised by the Data Controller in 2022 and in subsequent years, and for the purpose of compliance with the legal obligations of the Data Controller (in particular as regards tax settlements and accounting documentation), 3. my personal data will be processed on the basis of: GDPR Article 6.1.a) (i.e. freel given consent), GDPR Article 6.1.c) (i.e. compliance with the legal obligations to which the Data Controller is subject as regards tax settlements and accounting documentation) and GDPR Article 6.1.f)—legitimate interests of the Data Controller (i.e. direct marketing purposes of the Data Controller, especially related to the advertising, promoting, organising and holding of the International Fair of Amber & Jewellery Amberif, organised by the Data Controller in 2022 and in subsequent years),
